
SOCIAL SERVICES

IHDE's social service partner platform, Aunt Bertha, is now live for all users! Live training sessions were hosted throughout Quarter 1, and training videos are now available on our website. PRESCRIPTION DRUG MONITORING

The availability of Idaho's prescription drug monitoring program (PDMP) data is now available in the IHDE Clinical Portal. This new feature enables providers the ability to view real-time prescription information within the context of the patient's longitudinal record of care.



CONSENT MANAGEMENT

IHDE recently announced a new partnership with Leap Orbit to implement its Consentric consent management toolkit. The partnership will enable IHDE to expand its services to behavioral health providers, facilitating the sharing of mental health and substance use disorder (SUD) information with patient approval.

UPDATES & NEW SERVICES

Throughout the first quarter of 2021, IHDE continued its groundbreaking effort to make technology enhancements while curating an array of tools aimed at improving patient outcomes. IHDE continues to work on a variety of projects, improving our robust super-dataset that goes beyond traditional health information exchange. Through our SDoH tool, access to Idaho's PDMP, and our new consent management project, IHDE continues to innovate while maintaining our reputation as the trusted data trading partner, improving quality of health outcomes and reducing the cost of care.



IHDE and Aunt Bertha's shared social services platform is now available to ALL IHDE users and participants! Aunt Bertha's social care network connects verified social care providers with people seeking help. You can access and utilize the tool, including the PRAPARE assessment, to help



patients and clients connect with community based organizations in their area. The tool is already being utilized by a variety of IHDE partners, and we hope to see its continued use and growth throughout the state! To learn more and see our video, <u>click here</u>.

Prescription Drug Monitoring

IHDE recently added new capabilities to it's Clinical Portal platform, including the ability to view the prescription drug monitoring program. The availability of the PDMP in the IHDE Clinical Portal enables providers in your organization to make more informed clinical decisions at the point of care. This feature increases the ability of the provider to access prescription drug information within the context of the patient's longitudinal record of care, helping healthcare providers make critical clinical decisions, including the prescribing and dispensing of controlled substances.

Leap Orbit- Consent Management

IHDE's recent partnership with Leap Orbit enables the sharing of mental health and substance use disorder (SUD) information with patient approval. The partnership reflects the broader trend in healthcare to treat the whole person by integrating behavioral health services with the physical healthcare infrastructure. Leap Orbit's Consentric toolkit enables healthcare organizations to rapidly configure and deploy streamlined digital consent workflows, which will be made widely available to users via initial integrations with IHDE's clinical portal and master patient index. As a result, clinicians across Idaho will be able to obtain patient consent quickly and easily during any patient encounter. To maintain patient privacy preferences and safeguard sensitive health information, patients will be able to choose from several data sharing profiles that address their medical and behavioral health information. IHDE hopes this tool will aid Idaho's providers by improving coordination across the continuum of care.
